

Triathlon Canada Discipline and Complaints Policy

Definitions

1. The following terms have these meanings in this Policy:
 - a) “*Case Manager*” – An independent individual appointed by Triathlon Canada to administer complaints under this *Discipline and Complaints Policy*. “
 - b) “*Complainant*” – The Party making a complaint
 - c) “*Days*” – Days including weekends and holidays
 - d) “*Individuals*” – All categories of membership defined in Triathlon Canada’s Bylaws, as well as all individuals employed by, or engaged in activities with, Triathlon Canada including, but not limited to, registrants, athletes, national team representatives, coaches, support team individuals, officials, volunteers, administrators, directors and officers of Triathlon Canada, spectators at events, and parents/guardians of athletes
 - e) “*Respondent*” – The Party responding to the complaint

Purpose

2. Individuals are expected to fulfill certain responsibilities and obligations including, but not limited to, complying with Triathlon Canada’s policies, Bylaws, rules and regulations, and *Code of Conduct and Ethics*. Non-compliance may result in sanctions pursuant to this Policy.

Application of this Policy

3. This Policy applies to all Individuals.
4. This Policy applies to matters that may arise during Triathlon Canada’s business, activities, and events including, but not limited to, competitions, practices, tryouts, training camps, travel associated with Triathlon Canada’s activities, and any meetings.
5. This Policy also applies to Individuals’ conduct outside of Triathlon Canada’s business, activities, and events when such conduct adversely affects relationships within Triathlon Canada (and its work and sport environment), is detrimental to the image and reputation of Triathlon Canada, or upon the acceptance of Triathlon Canada based on their sole discretion. Applicability will be determined by Triathlon Canada at its sole discretion.
6. This Policy does not prevent immediate discipline or sanction from being applied as reasonably required. Further discipline may be applied according to this Policy. Any infractions or complaints occurring within competition will be dealt with by the procedures specific to the competition, if applicable. In such situations, disciplinary sanctions will be for the duration of the competition, training, activity, or event only.
7. An employee of Triathlon Canada who is a Respondent will be subject to appropriate disciplinary action per Triathlon Canada’s policies for human resources, as well as the employee’s Employment Agreement, if applicable. Violations may result in a warning, reprimand, restrictions, suspension, or other disciplinary actions up to and including termination of employment.

Alignment

8. Triathlon Canada recognizes that Individuals may also be registered with Provincial/Territorial Organizations and/or Member Clubs. Triathlon Canada requires Provincial/Territorial Organizations and/or Member Clubs to submit discipline decisions involving Individuals to Triathlon Canada and Triathlon Canada, at its discretion, may take further action.

9. If Triathlon Canada decides to take further action upon becoming aware of an Individual who has been disciplined by a Provincial/Territorial Organization and/or Member Club, the Individual will be the Respondent to a complaint initiated under the terms of this Policy. Triathlon Canada may act as the Complainant if the original Complainant is unwilling or unavailable to participate in this process.

Adult Representative

10. Complaints may be brought for or against an Individual who is a minor. Minors must have a parent/guardian or other adult serve as their representative during this process.
11. Communication from the Case Manager, as applicable, must be directed to the minor's representative.
12. A minor is not required to attend an oral hearing, if held.

Process

13. Any Individual may report an incident or complaint to Triathlon Canada in writing.
14. At Triathlon Canada's discretion, Triathlon Canada may act as the Complainant and initiate the complaint process under the terms of this Policy. In such cases, Triathlon Canada will identify an individual to represent Triathlon Canada.
15. A Case manager will be appointed as described in this Policy.
16. The Case Manager may determine that the alleged incident may contain an element of discrimination, harassment, workplace harassment, workplace violence, sexual harassment, or abuse. In this case, the Case Manager **must** appoint an independent third party to investigate the complaint. Triathlon Canada must also adhere to any reporting requirements mandated by the federal government. Upon completion of the investigation, the Case Manager will determine the appropriate Process to manage the complaint.
17. When the Case Manager determines that the alleged incident **does not** contain an element of discrimination, harassment, workplace harassment, workplace violence, sexual harassment, or abuse, or the investigation is complete, the Case Manager has discretion to choose which process should be followed, and may use the following examples as a general guideline:
 - a) Process #1 - the Complaint alleges the following incidents:
 - i. Disrespectful conduct
 - ii. Minor incidents of violence (e.g., tripping, pushing, elbowing)
 - iii. Conduct contrary to the values of Triathlon Canada
 - iv. Non-compliance with Triathlon Canada's policies, procedures, rules, or regulations
 - v. Minor violations of Triathlon Canada's *Code of Conduct and Ethics*
 - b) Process #2 - the Complaint alleges the following incidents:
 - i. Repeated minor incidents
 - ii. Major incidents of violence (e.g., fighting, attacking, sucker punching)
 - iii. Pranks, jokes, or other activities that endanger the safety of others
 - iv. Conduct that intentionally interferes with a competition or with any athlete's preparation for a competition
 - v. Conduct that intentionally damages Triathlon Canada's or its partner's or sponsor's image, credibility, or reputation

- vi. Consistent disregard for Triathlon Canada's bylaws, policies, rules, and regulations
- vii. Major or repeated violations of Triathlon Canada's *Code of Conduct and Ethics*
- viii. Intentionally damaging Triathlon Canada's property or improperly handling Triathlon Canada's monies
- ix. Abusive use of alcohol, any use or possession of alcohol by minors, or use or possession of illicit drugs and narcotics
- x. A conviction for any *Criminal Code* offense
- xi. Any possession or use of banned performance enhancing drugs or methods

Process #1: Handled by Discipline Chair

Sanctions

18. Following the determination that the complaint or incident should be handled under Process #1, the Case Manager will appoint a Discipline Chair who will review the submissions related to the complaint or incident and determine one or more of the following sanctions:
- a) Verbal or written reprimand
 - b) Verbal or written apology
 - c) Service or other contribution to Triathlon Canada
 - d) Removal of certain privileges
 - e) Suspension from certain teams, events, and/or activities
 - f) Suspension from all Triathlon Canada's activities for a designated period
 - g) Any other sanction considered appropriate for the offense
19. The Discipline Chair will inform the Respondent of the sanction, which will take effect immediately, upon acceptance of the Respondent.
20. Records of all sanctions will be maintained by Triathlon Canada.

Request for Reconsideration

21. The sanction may not be appealed until the completion of a request for reconsideration. However, the Respondent may contest the sanction by submitting a Request for Reconsideration within four (4) days of receiving the sanction. In the Request for Reconsideration, the Respondent must indicate:
- a) Why the sanction is inappropriate;
 - b) All evidence to support the Respondent's position; and
 - c) What penalty or sanction (if any) would be appropriate.
22. Upon receiving a Request for Reconsideration, the Discipline Chair may decide to accept or reject the Respondent's suggestion for an appropriate sanction.
23. Should the Discipline Chair accept the Respondent's suggestion for an appropriate sanction, that sanction will take effect immediately.
24. Should the Discipline Chair not accept the Respondent's suggestion for an appropriate sanction, the initial complaint or incident will be handled under Process #2 of this Policy.

Process #2: Handled by Case Manager

Case Manager

25. Following the determination that the complaint or incident should be handled under Process #2, the Case Manager has a responsibility to:
- a) Determine whether the complaint is frivolous and/or within the jurisdiction of this Policy

- b) Propose the use of mediation
- c) Appoint the Discipline Panel, if necessary
- d) Coordinate all administrative aspects and set timelines
- e) Provide administrative assistance and logistical support to the Discipline Panel as required
- f) Provide any other service or support that may be necessary to ensure a fair and timely proceeding

Procedures

26. If the Case Manager determines the complaint is:
- a) Frivolous or outside the jurisdiction of this Policy, the complaint will be dismissed immediately
 - b) Not frivolous and within the jurisdiction of this Policy, the Case Manager will notify the Parties that the complaint is accepted and of the applicable next steps
27. The Case Manager's decision to accept or dismiss the complaint may not be appealed.
28. The Case Manager will establish and adhere to timelines that ensure procedural fairness and that the matter is heard in a timely fashion.
29. After notifying the Parties that the complaint has been accepted, the Case Manager may propose using mediation with the objective of resolving the dispute. If applicable, and if the dispute is not resolved, or if the parties refuse to use of mediation, the Case Manager will appoint a Discipline Panel, which shall consist of a single Arbitrator, to hear the complaint. At the discretion of the Case Manager, a Discipline Panel of three persons may be appointed to hear the complaint. In this event, the Case Manager will appoint one of the Discipline Panel's members to serve as the Chair.
30. The Case Manager, in cooperation with the Discipline Panel, will then decide the format under which the complaint will be heard. This decision may not be appealed. The format of the hearing may be an oral in-person hearing, an oral hearing by telephone or other communication medium, a hearing based on a review of documentary evidence submitted in advance of the hearing, or a combination of these methods. The hearing will be governed by the procedures that the Case Manager and the Discipline Panel deem appropriate in the circumstances, provided that:
- a) The Parties will be given appropriate notice of the day, time, and place of the hearing, in the case of an oral in-person hearing or an oral hearing by telephone or other communication medium
 - b) Copies of any written documents which the parties wish to have the Discipline Panel consider will be provided to all Parties, through the Case Manager, in advance of the hearing
 - c) The Parties may engage a representative, advisor, or legal counsel at their own expense
 - d) The Discipline Panel may request that any other individual participate and give evidence at the hearing
 - e) The Discipline Panel may allow as evidence at the hearing any oral evidence and document or thing relevant to the subject matter of the complaint, but may exclude such evidence that is unduly repetitious, and shall place such weight on the evidence as it deems appropriate
 - f) The decision will be by a majority vote of the Discipline Panel
31. If the Respondent acknowledges the facts of the incident, the Respondent may waive the hearing, in which case the Discipline Panel will determine the appropriate sanction. The Discipline Panel may still hold a hearing for the purpose of determining an appropriate sanction.
32. The hearing will proceed in any event, even if a Party chooses not to participate in the hearing.

33. If a decision may affect another party to the extent that the other party would have recourse to a complaint or an appeal in their own right, that party will become a Party to the current complaint and will be bound by the decision.
34. In fulfilling its duties, the Discipline Panel may obtain independent advice.

Decision

35. After hearing and/or reviewing the matter, the Discipline Panel will determine whether an infraction has occurred and, if so, the sanctions to be imposed. Within fourteen (14) days of the hearing's conclusion (if held), the Discipline Panel's written decision, with reasons, will be distributed to all Parties, the Case Manager, and Triathlon Canada. In extraordinary circumstances, the Discipline Panel may first issue a verbal or summary decision soon after the hearing's conclusion, with the full written decision to be issued before the end of the fourteen (14) day period. The decision will be considered a matter of public record unless decided otherwise by the Discipline Panel.

Sanctions

36. The following disciplinary sanctions may be applied, singularly or in combination:

- a) Verbal or written reprimand
- b) Verbal or written apology
- c) Service or other contribution to Triathlon Canada
- d) Removal of certain privileges
- e) Suspension from certain teams, events, and/or activities
- f) Suspension from all Triathlon Canada's activities for a designated period
- g) Payment of the cost of repairs for property damage
- h) Financial Penalty
- i) Probationary terms and conditions
- j) Repeal of acknowledgements or rescind awards
- k) Suspension of funding from Triathlon Canada or from other sources
- l) Expulsion from Triathlon Canada
- m) Any other sanction considered appropriate for the offense

37. Unless decided otherwise, any disciplinary sanctions will begin immediately, notwithstanding an appeal. Failure to comply with a sanction as determined by the Discipline Panel will result in an automatic suspension until such time as compliance occurs.

38. Records of all decisions will be maintained by Triathlon Canada.

Appeals

39. The decision of the Discipline Panel, as applicable, may be appealed in accordance with Triathlon Canada's *Appeal Policy*.

Suspension Pending a Hearing

40. Triathlon Canada may determine that an alleged incident is of such seriousness as to warrant suspension of an Individual pending completion of a criminal process, the hearing, or a decision of the Discipline Panel.

Criminal Convictions

41. An Individual's conviction for a *Criminal Code* offense, as determined by Triathlon Canada, will be deemed an infraction under this Policy and will result in expulsion from Triathlon Canada. *Criminal Code* offences may include, but are not limited to:

- a) Any child pornography offences
- b) Any sexual offences
- c) Any offence of physical violence
- d) Any offence of assault
- e) Any offence involving trafficking of illegal drugs

Confidentiality

42. The discipline and complaints process is confidential and involves only Triathlon Canada, the Parties, the Case Manager, the Discipline Panel, and any independent advisors to the Discipline Panel. Once initiated and until a decision is released, none of the Parties will disclose confidential information relating to the discipline or complaint to any person not involved in the proceedings.

Timelines

43. If the circumstances of the complaint are such that adhering to the timelines outlined by this Policy will not allow a timely resolution to the complaint, the Discipline Panel may direct that these timelines be revised.

Records and Distribution of Decisions

44. Other individuals or organizations, including but not limited to, national sport organizations, provincial sport organizations, sport clubs, etc., may be advised of any decisions rendered in accordance with this Policy.
